9.a Scope

The area where EKOTAR, TÜRKAK, IOAS, GOTS, TR, EU Organic Logo are used.

9.b Aim

Describing the method of following up compliance" logo, cerificate and marks" rules and actions taken when non-compliances are detected.

9.c Responsibilities

Quality Manager, Certifier and auditor are the responsible persons.

9.d Execution

This document describes the conditions concerning publication and use of certification logos (Ekotar, Türkak, GOTS, EU/TR/NOP, IOAS) Organic by customers of EKOTAR (the Certificate-holder) with a valid Certificate.

1. EKOTAR Logo

1.1 The Certificate-holder can only publish those certification-logos that are concerning the valid issued Certificate, and does not make or permit any misleading statement regarding its certification, nor imply that the certification applies to activities that are outside the scope of certification.

1.2 The certification logo may never be bigger than the size of the company logo on the same document.

1.3 When the Certificate-holder does not respect these conditions for use of certification logos, the Certificate-holder will stop immediately, without delay, the use against which EKOTAR has objected. EKOTAR can take the following measurements; suspension or withdrawal of the Certificate; publication of the non-compliance; juridical procedures. The action taken is depending on the severity of the non-compliance.

1.4 In case the validity of the Certificate is ended, for whatever reason, the Certificate-holder has to stop immediately with the use and/or distribution of promotion material on which the certification logo is printed.

1.5 The logo needs to be reproduced completely (in one piece) always.

1.6 It is not allowed to use the accreditation logo only.

1.7 EKOTAR logo can be used in original Green&Red colour, as well as in black and white. It's height shouldn't be less than 8 mm.

The IOAS has set out rules for use of the IOAS name and the IOAS accreditation symbol in document PL0515. Accredited CBs may use the IOAS accreditation symbol on its certificates issued within the scope of the accreditation and, with certain limitations, on their web site. On suspension or withdrawal

7. GOTS Logo and Labelling

7.1 The International Working Group on Global Organic Textile Standard (IWG) has developed and is continuously revising the Global Organic Textile Standard (GOTS) and is its sole owner. The GOTS picture-mark, also represented as "GOTS logo" or "GOTS label", is copyright material and is a registered trademark owned by the IWG. The use of the GOTS picture-mark is regulated and governed by the IWG; unauthorised use of this copyright material is prohibited and may lead to legal action.

7.2 As per the GOTS Labelling Guide, it is a requirement to have any use of the GOTS Logo approved by Certification Bodies prior to use of the logo.

- The example of the label must contain the logo, correct references to the product ('label grades' organic / made with x% organic) and EKOTAR client number.
- The verification of correct logo use is done by EKOTAR auditor during the GOTS audit.
- Keep proof of the use as a record in the administrative offices of your company for the auditor to check this form.

7.3 GOTS logo use requirements document provided by the GOTS International Working Group, the following rules apply with regards to GOTS labeling:

- Use of the GOTS logo is optional. Prior approval is required from EKOTAR certifier before use. An additional charge for approval is applied. The GOTS logo is also valid for all products that are certified by EKOTAR according to the Global Organic Textile Standard (GOTS), provided that it mentions on the indications that the product has been certified by EKOTAR according to the Global Organic Textile Standard.
- Label grades, "organic textile product" and "textile product made with (x%) organic raw material" must be presented in the label. (x%) is optional.
